## About the Seminar

The widely publicised incident at the Christian Zheng Sheng Association, a charity set up to help adolescents with drug addictions, whose directors were arrested on suspicion of conspiracy to defraud HK\$50 million in donations has drawn considerable attention to the adequacy of governance of charitable institutions in Hong Kong.

Drawing comparisons with other jurisdictions, this seminar will seek to put forward some suggestions to improve its regulatory framework for charities and increase the awareness of the need for good governance in this sector.

## About the Presenters

**Chee Keong Low ('CK')** retired as an Associate Professor in Corporate Law on 1 August 2022 after more than three decades at The Chinese University of Hong Kong Business School. His research in issues pertaining to corporate governance and the regulatory framework of capital markets published in journals in Australasia, Europe and the United States of America.

A non-practising Advocate and Solicitor of the High Court of Malaya, CK is currently a member of the statutory Advisory Committee of the Accounting and Financial Reporting Council as well as of the Standing Committee on Company Law Reform in Hong Kong. Amongst others he previously served on the Listing Committee of The Stock Exchange of Hong Kong as well as on the Securities and Futures Appeals Tribunal.
